

OFFICIAL RULES

1. How to Enter: **NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. VOID WHERE PROHIBITED.** Beginning at 12:00 a.m. Eastern Time ("ET") on Friday, February 20, 2009 until 11:59 p.m. ET on Thursday, September 24, 2009 ("Sweepstakes Period"), you may enter the Lincoln Electric Welder Give-Away Sweepstakes (the "Sweepstakes") by visiting the websites, www.tvmechanic.com/truckutv or www.tvmechanic.com/twoguysgarage and completing and submitting the online entry form. Limit one (1) entry per person and per e-mail address for the entire Sweepstakes Period. If an entrant uses multiple e-mail addresses to submit more than one (1) entry, only the first entry received from such per person or email address will count and all additional entries will be void. Entries generated by script, macro or other automated means are void. By entering, entrants may receive information via email from Sponsor. Entrant can opt-out of receiving these offers at any time. 2. Agreement to Official Rules: By participating in this contest, entrants agree to abide by the terms and conditions of these Official Rules, as established by Sponsor. Sponsor reserves the right to qualify all submissions and to reject any submissions that do not meet the requirements for participation as established by Sponsor.

3. Eligibility: This Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are 21 years of age or older. Void outside the fifty (50) United States and the District of Columbia and where prohibited. Employees of Brenton Productions, Inc.
